RE: Proposed Amendments to Bylaw 18155, Council Procedures Bylaw

Mayor and Council:

On behalf of the Edmonton Chamber of Commerce (ECC), I am writing to express strong opposition to *Bylaw 20915 – Amendments to Bylaw 18155 – Council Procedures Bylaw*, which will be considered at the <u>August 20, 2024, City Council meeting</u>. This bylaw responds to the following motion that was passed at the July 4, 2024, City Council meeting:

That Administration prepare amendments to Bylaw 18155, Council Procedures Bylaw, to change the distribution date for agendas from 10 clear days prior to the meeting to the Thursday prior to the meeting.

The proposed bylaw change is ill-advised, poorly conceived, and highly problematic. If approved, it will impair the accessibility, accountability, and transparency of Council's decision-making, and it will limit the ability of Edmontonians from fully participating in local democracy. This change raises several concerns that I believe warrants further consideration:

- Accessibility: The current requirement of publishing agendas 10 clear days prior to the
  meeting provides citizens, businesses, media outlets, advocacy groups, and elected officials
  adequate time to review meeting materials thoroughly. This period is crucial for creating
  awareness of municipal issues, conducting necessary research, engaging constituents and
  elected officials, and formulating informed opinions. Reducing this timeframe to just a few
  days before the meeting significantly limits accessibility to municipal affairs and will lead to
  rushed or uninformed decision-making.
- Accountability: City Council plays a critical role in ensuring the accountability of City Administration, particularly as it relates to delivery of public services and management of taxpayer dollars. At the same time, Edmontonians play a critical role in ensuring the accountability of City Council as representatives of the electorate. Reducing the timeframe in which the public and elected officials have access to meeting materials significantly impairs their ability to uphold the integrity of local democracy and in holding municipal government to account.

• Transparency: Adequate notice and time for review are fundamental to maintaining transparency and fostering public engagement in the municipal decision-making process. The current 10-day period ensures that the public has sufficient time to access, understand, and provide feedback on agenda items. Shortening this period will undermine public confidence and reduce opportunities for meaningful community participation. This is especially true for individuals from diverse or traditionally underrepresented groups. A transparent and accessible decision-making process is essential for a thriving and resilient Edmonton, and for ensuring elected officials make informed decisions on behalf of their constituents.

It was concerning to witness select members of Council vote in favor of this proposed bylaw amendment which runs counter to Council's and the public's interest. With additional time to consider the impacts of the change, I am cautiously optimistic that Council has further considered the impact the proposed bylaw amendment will have on their abilities to govern, adequately engage their constituents, and make informed decisions.

Lastly, I'd like to highlight that the process by which this direction was provided is concerning. The motion, which was half of a two-part motion, appears to have been made in haste at the conclusion of the final City Council meeting before summer recess. As a "motion pending" on the July 4, 2024, City Council agenda, limited public communication, analysis, or engagement was conducted as part of the decision-making process, despite its significant impact on public accessibility, accountability, and transparency. Furthermore, given the resulting amending bylaw will go directly to City Council for approval on August 20, 2024, Edmontonians will not have an opportunity to speak in favour or against the proposed bylaw change, per City Council's public speaker protocols.

As such, on August 20, 2024, I urge City Council to put forward a motion to reconsider this decision from the July 4, 2024, City Council meeting, and to explicitly direct City Administration to maintain the current 10-day agenda distribution requirement.
