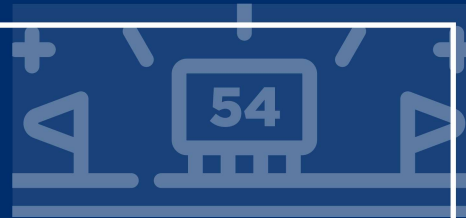

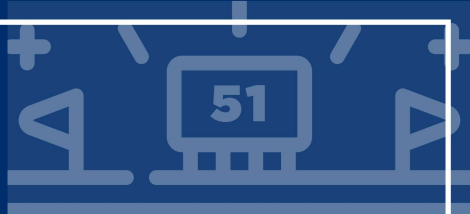

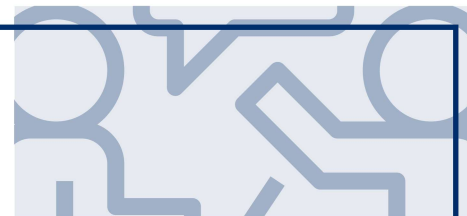
3 program cohorts hosted
