

# TRAFE ACCELERATOR PROCRAM (TAP)

Exporting can be daunting, costly and time consuming, limiting many businesses' opportunities for growth. The Trade Accelerator Program (TAP) connects small to medium-sized enterprises with industry experts who help each participant develop and execute a personalized market-entry export plan.

This program is the most comprehensive of its kind in our region. Its combination of intensive workshops, peer-to-peer exchange and individual mentoring from leading Canadian export advisors gets participants ready to go global in no time.

In 2022, following several successful cohorts over the last three years, the Edmonton Chamber of Commerce supported the Calgary Chamber in offering TAP to a cohort of Indigenous business owners. We were also proud to run the program for another cohort of our own in the fall, with a total of 13 businesses participating.

#### **2022 HIGHLIGHTS**

- Participants' average total revenue grew by approximately 40% within one year of completing the program
- 95% of participants indicated that TAP and writing the export plan were helpful in preparing them for export activities
- 55% of companies sourced financing as a result of TAP, with an average financing amount of \$1,206,575

"Venturing into the world of export can be a maze of confusion and uncertainty. TAP helped me unravel that maze and gave me a new set of tools that allowed me to establish a clearly focused plan designed to help me realize my export vision. The program not only connects you with leading experts in a variety of fields, but also helps you dial into the more complex details of international trade that perhaps aren't otherwise apparent or intuitive.

It helped us find international trade partners and launch our brand in both Japan and Korea! I encourage anyone who is interested in better defining and actualizing their own export journey to enroll in TAP."

If those students want to meet local industry leaders, learn about issues facing the business community, and find workshops and career development opportunities to help them reach their goals, we say it's never too early to start!

In 2022 we soft launched our student membership program, introducing an affordable way for post-secondary students to join our community of members. For just \$49 a year, students gain access to our network of highly connected professionals, our robust calendar of learning, networking and advocacy events, and even leadership opportunities – as of this year, two of our student members are serving on Chamber committees.

People start businesses for a lot of reasons; some do it for money and others for fame, but for my family and I, we wanted to help grow the diverse eco-system within Alberta, especially within the Asian communities. I was born and raised in the Philippines and moved to Taiwan once I finished my education. After spending two years exploring the world of residential and commercial cleaning, I embarked on my journey to Fort McMurray, Alberta.

After spending a few years working as a nanny as I integrated into western society, I was inspired to jump right into the deep end and start my own cleaning company, Hyklen Services. It was then that I found out how impactful networking can be for a business, especially a Startup. The company started off as residential cleaning only, but as the need grew, so did our business. We then added commercial and industrial cleaning, which includes foreclosure. The cleaning didn't stop there, as we added snow removal & bin rentals to our services. Hyklen Services currently operates in both Edmonton and Fort McMurray.

As serial entrepreneurs, we wanted to look at other ways we can provide reliable, trusted services to the local ecosystem, so we opened CentreTech Automotive and Welding. CentreTech offers a full range of mechanical services in Edmonton and surrounding areas, and a wide range of welding services catering to both Edmonton and Fort McMurray. Our welding service is completely mobile, we'll come to you, anytime, anywhere.

Having access to networks at the start of my business journey was vital to the growth of Hyklen Services. Since we just expanded into Edmonton, we are so excited to join the business network out here, and there's no better way than through the Edmonton Chamber of Commerce!

#### **2022 HIGHLIGHTS**

This year we dug deep into our newsletter data to see how well the newsletter meets member needs. The open rate was already higher than industry average, but we increased that rate further by tailoring content more tightly to the news that impacts Edmonton businesses most.

#### → Elder in Residence

We furthered our work with Enoch Cree Nation by partnering with our Elder in Residence, Elder Irene Morin. Elder Morin's perspectives and input guided us in relation to **National Truth and Reconciliation** Day and Indigenous Veterans Day, and we connected her with other corporations in the region so they could access her knowledge as well.

#### $\rightarrow$ Sharing news that matters $\rightarrow$ New events, new opportunities

We launched and hosted new marquee events in 2022, including the State of the Region. This new event, which engaged our entire region in a conversation about the criticality of regional collaboration, sold out in under two weeks.

#### → Strategic partnerships and alignment

We aligned our strategy for the four-year municipal budget with three other memberfunded organizations: BOMA, NAIOP Edmonton and UDI Edmonton. Sharing strong key messages across our organizations aligned Edmonton's business community and strengthened our collective voice as we made the following asks of the City:

- Better define priorities
- Allow for more agility and flexibility
- Focus on the mandates of municipalities

As an organization deeply rooted in this community, we care about the future of Edmonton. We know that the next generation of business leaders, entrepreneurs, policy makers and community visionaries are children in Edmonton's schools today—and we know it's hard to learn, grow, play, and make your dreams happen if you're hungry.

E4C's School Lunch Program feeds 2,100 students from kindergarten to grade six at ten Edmonton schools. With this basic need met, schools have seen students' attendance, morale and concentration improve. The Edmonton Chamber of Commerce was proud to donate \$30,566 to the School Lunch Program in 2022—our contribution to help families make it through these challenging times and set the next generation up for success.

#### **ELDER IN RESIDENCE**

At 5% of our overall population, Edmonton has the second largest urban Indigenous population in Canada. Indigenous people in the region have a powerful role to play in Edmonton's economic future, but often face systemic barriers to inclusion. As a Chamber, we can and should use our platform to help reduce those barriers, prioritize Indigenous voices and advance our community's journey of reconciliation.

In June 2022, we were honoured to welcome our first Elder in Residence. Since her appointment this past summer, Elder Irene Morin of the Enoch Cree Nation has provided important guidance to us, to our broader membership, and to other political and community leaders who shape our city. With an indomitable spirit, resilience, optimism, and deep pride in her culture, people and community, Irene has tirelessly dedicated her life to building bridges and advancing the interests of Indigenous peoples.

Irene's extensive career included working in the 1960's for what was then the Department of Indian Affairs, and later for the Edmonton Separate School Board, Native Counselling Services of Alberta, Native Friendship Centre, the Senate of Canada in Ottawa, and for the Enoch Cree Nation for nearly 30 years. As a survivor of the Blue Quills Indian Residential School in Alberta, she was involved in grassroots activism that made Blue Quills the first school officially administered by Indigenous representatives in 1970. Now called University nuhelot'jne thaiyots'j nistameyimâkanak Blue Quills, the school is an example of a successful, independent Indigenous educational institution—with a mandate to "advance and protect Indigenous forms of life and thinking through teaching, research and community service, guided by the natural laws of the Cree people and grounded in the Cree language."

In 2017, she received both the Queen Elizabeth II Golden Jubilee Medal and the Senate of Canada 150th Anniversary Medal, recognizing her outstanding contributions to her local community and Canadian society. As those accolades suggest, Irene's dedication over the course of her career has enriched countless lives and created meaningful change. We thank Irene wholeheartedly for sharing her knowledge and experience with us, and we look forward to working together further in the coming year.



# POLISY AND ADVOCACY

Our job creators—from small local enterprises to large corporations—are the economic engine that drives our country. As one of the longest-standing business organizations in Canada, the Edmonton Chamber of Commerce uses our powerful voice to influence decisions made by every order of government, ensuring businesses have the competitive conditions they need to succeed.

Policymakers rarely set out to hurt businesses, but without access to an expert perspective, they may not see the full implications of their decisions. Our role is to provide that perspective, and to raise the alarm when we see risks to our community's economic future. On issues from property tax rates to community safety and wellbeing, we ensure the voice of Edmonton's business community is heard.

#### 2022 POLICY HIGHLIGHTS

Working alongside our network partners with the Alberta Chambers of Commerce, the Canadian Chamber of Commerce and the Canadian Global Cities Council, the Edmonton Chamber added our members' voices to provincial and national conversations and raised awareness of issues facing businesses throughout the year. Some of the important advocacy work included:

#### COMMUNITY SAFETY AND WELLBEING

Edmonton continues to need significant investment to improve community safety and support the social programs that help vulnerable people connect with the right help at the right time. Through advocacy to all levels of government, we continue to call for action to address community safety and wellbeing priorities to improve the quality of life in our city.

#### TALENT ATTRACTION SKILLS DEVELOPMENT

Many industries are facing a shortage of workers. Our Chamber Team called on the government to promote Edmonton and Alberta nationally and internationally to support the growth of talent in our region.

#### Paired with a labour shortage,

there are many people unable to find work, resulting in a skills gap. We advocated for increased capacity in the post-secondary education system to support skill development in high-priority fields and for expansion of work-integrated learning opportunities to help bridge this gap so all Albertans can find meaningful employment.

#### **TRADE BARRIERS**

Supply chain challenges continue to affect businesses due to a variety of factors. We continue to press all orders of government for the removal of national and international trade barriers to reduce barriers where possible.

#### CONNECTIVITY

Businesses increasingly rely on internet connectivity, yet many of our surrounding areas don't have access. We advocated for continued investment in broadband internet connectivity to support robust business communications across the province.

#### **CHILDCARE**

Quality, affordable early learning and childcare is a high priority for businesses as it boosts workforce participation, productivity, and talent attraction. We advocated for investments in Early Learning and Child Care to expand affordable, accessible and high-quality childcare spaces.

# FINANSE AND OPERATIONS

In 2022, the Chamber of Commerce demonstrated its unwavering commitment to supporting the local business community through its sponsorships of various initiatives and events, totalling \$17,380.74.
